

## **“RENTAL AGREEMENT”**

### ***Be Adventurous Rentals***

**\*\*\*YOU MUST READ AND AGREE TO ALL TERMS OF THIS RENTAL AGREEMENT, WAIVER AND RELEASE\*\*\***

#### **1. General Policies**

- a.) Government issued photo ID and/or a Current Driver’s License is required at the time of pick-up.
- b.) You must be 18 years old or older to rent. The individual(s) named on the contract is/are required to submit credit card information and a deposit at the time of reservation or rental.
- c.) Payment in full for all equipment rentals is due at the time of reservation or rental. *Be Adventurous Rentals* reserves the right to refuse service to any individual(s) at their sole discretion.

#### **2. Cancellation Policy (all refunds based on subtotal)**

- a.) Cancellations made five (5) days or more before date of pick-up
  - i.) Customer will receive a 90% refund (minimum \$1.00 retained by *Be Adventurous Rentals*).
- b.) Cancellations made within four (4) to one (1) day(s) before date of pick-up:
  - i.) Customer will receive a 50% refund (minimum \$1.00 retained by *Be Adventurous Rentals*).
- c.) Cancellations made twenty-four (24) hours or less before date of pick-up:
  - i.) Customer will not receive a refund.
- d.) No refunds will be given for reason of illness, weather, early returns or non-usage.
- e.) The individual(s) named on the contract must be present at the time of pick-up or equipment will not be released.

#### **3. Pick-Up Procedure**

- a.) Before accepting any rental equipment, you are responsible for inspecting all equipment carefully. You must bring any missing or damaged equipment to a staff member's attention.
- b.) You are responsible to ensure that any equipment discrepancies are noted on the rental agreement. Failure to note equipment discrepancies may result in a fee being charged for damaged and/or missing equipment. If required, please ask a staff member for assistance with inspection and/or instructions on how to properly setup the equipment.
- c.) It generally takes 10-15 minutes to check out equipment. Please consider this as you make your reservation. Deviation from this timeline may result in delays as equipment will not yet be prepared.

#### 4. Return Procedure

- a.) Equipment must be returned to *Be Adventurous Rentals*, at the rental location, within 1-hour of the time and date listed on your contract.
- b.) Equipment returned later than 1-hour from the date and time listed on the contract may incur a late fee. If the board(s) are returned late and effects a rental you will be charged the daily rate.
- c.) A cleaning fee of \$5.00 per piece of equipment will be collected if equipment is not returned in the same condition as when it left.
- d.) You will be charged for equipment that is dirty, damaged, or missing, up to and including the cost to replace such equipment at the current equipment cost, regardless of the age of the equipment.
- e.) If you leave equipment unattended (i.e. during closed hours) at *Be Adventurous Rentals*, you will be charged a \$25.00 fee regardless of the reason (unless written arrangements are made beforehand with a staff member).
- f.) Should you leave equipment unattended at *Be Adventurous Rentals* and the same is lost or stolen while unattended, you will be responsible for all replacement costs, which are made in *Be Adventurous Rentals* sole and unfettered discretion.
- g.) **Equipment Damage:** Your rental fee does not cover damage to equipment. If you damage equipment and it interferes with the rental or reservation of another customer, you will be charged the entire cost of any rentals interfered with as a result. In addition, you will also be charged the cost of equipment repair or replacement costs.

#### 5. Late Fees

- a.) Late fees are assessed at 1.5 times the daily rate for each day the equipment is not returned. This includes holidays and dates on which *Be Adventurous Rentals* is closed.
- b.) This is strictly enforced as it jeopardizes another person's trip. If equipment is returned late and it interferes with another customer's rental, you will be charged the entire cost for any and all rentals which are interfered with as a result.

#### 6. Location

- a.) You are responsible to ensure the location you choose to utilize the equipment on is safe. You acknowledge that you are aware of the dangerous lakes and rivers in the area such as, but not limited to, Abraham Lake and the North Saskatchewan River Crossing. You certify that you have the knowledge and skills to utilize the equipment safely, regardless of the location you choose to enjoy same.

#### 7. Equipment

- a.) You will be supplied the Stand-up Paddleboard, Paddle, Leash, Hand pump, Board bag, Seat, Life jacket (personal floatation device).

I HAVE READ AND UNDERSTOOD THE WAIVER AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS, AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.

I UNDERSTAND THAT I AM RESPONSIBLE FOR MY OWN SAFETY IN ALL ACTIVITIES AND UNDERSTAND THAT WEARING A PERSONAL FLOATATION DEVICE (PFD) WHILE OPERATING WATERCRAFT IS REQUIRED UNDER THE LAWS OF THE PROVINCE OF ALBERTA.
